TUITION AGREEMENT

Please review the below information carefully as you are required to confirm your acceptance when you pre-register your student on PowerSchool.

Parish Life:

- As a family, we agree to actively participate in the life of the parish. We will do this by regularly attending Mass, receiving the sacraments, and using the church tithing envelopes on a regular basis. We will follow through on our commitment throughout the year.
- Families who fulfill this commitment are eligible for the Parishioner Tuition Rate.
- As a Non-parishioner family we agree to pay the Non-Parishioner Tuition Rate.

Tuition Compliance Activity:

- All families commit to a designated tuition compliance activity(ies) on behalf of St. Patrick School in the 2022-2023 school year for a minimum of 15-20 hours. These activities are a primary source of fundraising revenue for our school which in turn keep our tuition low.
  - Families have the option to Cash Out (\$800) instead of the required hours.
  - Those families not fulfilling their assigned activities will be charged \$1,000.00 (\$200.00 surcharge over those making voluntary contribution in place of an assigned volunteer activity.)

Raffle:

- All families are required to purchase or sell at least \$300 worth of raffle tickets to the Spring Raffle.
  - Families who do not comply will be charged an additional \$300 in tuition before the end of the school year.

Tuition:

- All families must pay the tuition (noted below) in accordance with the schedule selected through the FACTS program.
  - If the tuition is not paid by the due date, a late fee will be charged (\$25 for each month by FACTs).
  - Families of students whose tuition in in arrears on the 1st day of the third trimester may not attend classes until account is brought current
  - Final tuition for all families is due in April in accordance with your selected FACTS payment plan. Report cards, awards, and diplomas will not be released until all accounts are paid in full.
  - Families of 8th graders whose tuition is not paid in full in accordance with your FACTS payment plan will have chosen non-participation for their child/children in the final class trip and will not receive a report card or a diploma.
  - Pre-registration in January for the following school year will be accepted only if the tuition account is current.
  - Note: Tuition Assistance/Empower will reflect in your FACTs account once approved.

Parishioner Rate (Annual):

1 Child - \$4,610.00    2 Children - \$8,070.00    3 Children - \$11,010.00    4 Children and up - \$13,780.00

Non-Parishioner Surcharge (Annual)

Families who are not parishioners of St. Patrick Parish are assessed a tuition surcharge per student.

1 Child - \$1,500.00    2 or more (per child) - \$750.00

Late Pick Up:

- Afternoon supervision is provided until 3:10 p.m. We allow 2 emergency late pick-ups per year. If a parent is late more than the allotted emergency days and you have not signed up for our After Care Program, you will be charged \$25 to your FACTs account.
